

Jerry and Diana Kitchen

It was a beautiful spring day. The rabbits thought so, too. Four of them were hopping over the beautiful and colorful flowers along the Manor walkways. Then, with my arrival at 8C, the beauty continued, for there beyond the sliding glass doors was a harmonious garden, with a quiet fountain and a whimsical red sculpture. After just two weeks of living there, Diana and Jerry Kitchen's home is complete, and they are so happy to be here. "We love our space. It's great and the people here are so friendly, and the staff is fabulous!" But, to start from the beginning...

Diana Schleinz was born and raised in Wisconsin. In high school, she was interested in drama, but when she graduated from Marquette University, in 1970, she had a degree in Philosophy and English Literature, a husband of two years, and a baby on the way. After son Alexander (Sasha) was born, the family moved to Fort Collins, CO, where her husband was getting his PhD in psychology at Colorado State University. This did not slow Diana down. She studied for her Master's in Philosophy, had a baby girl, Elizabeth, and got politically active. She cofounded the NOW (National Organization for Women) chapter in Fort Collins and became the coordinator of NOW for the state of Colorado. Her first project was eliminating the fee that women had to pay to use bathrooms at Denver's Stapleton Airport. She won that battle. When her husband accepted an internship at the Veteran's Administration, in Palo Alto, she enrolled in the USF School of Law. Diana got her degree – with honors - in 1978. After two years in the litigation department of PG&E, she became a partner in a Palo Alto law firm, so she could be closer to home with her two small children. She remained with the firm for her career, specializing in employment law and gender discrimination.

Long before all of this, in 1940, Jerry Kitchen was born in Kearney, Nebraska. Jerry was raised in Denver, but went to the U. of Wyoming to study journalism. A benefit of being in Wyoming was being able to work summers at the recently-completed Jackson Lake Lodge, in Grand Teton National Park. Of the 500 students selected, 300 were girls. (Jerry smiled, remembering this.)

After graduating from Ohio University with a Master's in Communications, he served three years in the air force, in Spain and Germany. After resigning his commission, he took a public relations job with General Electric in New York. He loved New York, but two years later he began law school at UC Hastings in San Francisco. He married after the first year, and, upon graduating, he and his wife moved to Phoenix, where he joined a law firm. Two years later, after the birth of his first son, Christopher, Jerry joined AMAX as general counsel of its exploration subsidiary in Denver. There, two more sons were born, Jeremy and Tim. Then life got fast and exciting. AMAX Exploration had 19 offices around the world, so Jerry traveled to many faraway places. It was a fascinating job.

In 1983, he became general counsel of Alumax, based in San Mateo, and the family moved to Atherton. When the company moved to Georgia years later, Jerry declined to follow. He became a partner with Diana's law firm and worked there until 1995, when he and a friend formed a new company, Century Aluminum, which they took public in 1996. The company was headquartered in Monterey, so Jerry moved to Pebble Beach. Having been divorced from their spouses years earlier, Jerry and Diana were married in Moose, Wyoming, in 1999. Jerry retired in 2006, and now they have the joy of seeing their melded family of five children and eleven grandchildren enjoy their annual visits to Wyoming.

Diana and Jerry enjoy sailing and belong to the St. Francis Yacht Club. They have sailed in Alaska, British Columbia, Maine, and New England. They have also participated in five vintage car events in their 1955 Jaguar roadster. Jerry is an avid amateur photographer; Diana likes to paint, play bridge, and quilt. Together they enjoy golf and hiking. They are avid readers and book club members.

Busy people? We think so. And with that, we welcome this happy couple to Carmel Valley Manor!
